Declaration of Conformity

The present Declaration of Elma Electronic AG refers to the EU directives and the national legislation listed below.



RoHS (Restriction of the use of certain Hazardous Substances) is the Directive on the restriction of use of certain hazardous substances in electrical and electronic equipment.

All Products of Elma Electronic AG are conform to applicable to the directive 2011/65/EU of the European Parliament and of the Concil of 8 June 2011 of RoHS III and 2015/863/EU on the restriction of the use of certain hazardous substances in electrical and electronic equipment and compliance with the maximum permitted concentration in homogeneous materials in percentages by weight <0.01% of cadmium (Cd), <0.1% of lead (Pb), mercury (Hg), cadmium (Cd), hexavalent chromium (Cr VI), polybrominated biphenyl (PBB), Polybrominated diphenyl ethers (PBDE), bis (2-ethylhexyl) phthalate (DEHP), benzyl butyl phthalate (BBP), dibutyl phthalate (DBP), diisobutyl phthalate (DIBP), in accordance with Annex II of the directive.

Additions to other "worrying substances"

We use nickel (Ni) as an element of surface treatments on some of our products. The concentration in ppm of the element (Ni) is dependent on the product and its mass.

For some rotary switches we use as an alloy of beryllium (Be) copper. Here we can only declare on the product concerned, the concentration in ppm also.

The RoHS status of our products is mentioned on our quotations as well as delivery documents.



REACH (Registration, Evaluation, Authorisation and Restriction of Chemicals) is the European Chemicals Regulation on Registration, Evaluation, Authorisation and Restriction of Chemicals – in order to improve the protection of human health and the environment from Chemical Hazards. Similarly, under the Directive falls compulsory registration of chemicals, but not finished products.

Elma Electronic AG is a manufacturer of enclosures and components for electronics, basic systems and rotary switches within the meaning of the REACH Regulation 1907/2006 a "downstream user".

Our goods are products and therefore should not be defined as a substance or preparation. In addition, no substance is released from our products under normal and foreseeable conditions of use. Thus, ELMA Electronic AG is not subject to the obligation to register or the obligation to compile safety data sheets.

To ensure our customers' continued supply of reliable and safe products, we ensure that our suppliers meet all chemical substance and material requirements, and therefore no substances from the Candidate List of Substances of Concern (SVHC) for the manufacture of our products be used.


